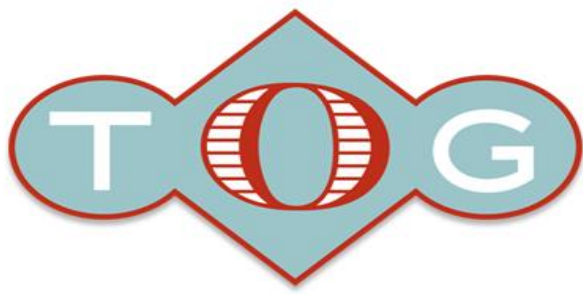

- Insurance Certificate
- Certificate of Origin (for distilled spirits and malt beverages only)
- Certificate of Health/Sanitation (for distilled spirits and malt beverages only)
- Certificate of Authenticity/Free Sale (for distilled spirits and malt beverages only)
- [Consolidated Wine Export Certificate \(for wine only\)](#)
- Certificate of Free Sale
- Sanitary Statement/Certificate
- Certificate of Manufacturing Process
- Consolidated Wine Export Certificate (for wine exported to China)
- Front and Back Labels of bottles
- Alcohol content
- Alcohol import license
- Commercial invoice
- Customs Value Declaration
- Freight Insurance/documents
- Packing List
